- 1. Meeting called to order by Kristi Jones, president @ 7:05 PM.
- 2. March 24, 2025 minutes reviewed, motioned by Jeanie Coley seconded by Caroline Jimmerson and approved.
- 3. Treasurer's Report (Kristi Jones and Lacy Moore)
 - a. Student account -beginning balance \$102,639.10, ending balance \$93, 469.81 (see treasurer report for details)
 - b. Parent account -beginning balance \$7962.78, ending balance \$2455.40 (see treasurer report for details)
 - c. Sammy savings account (fundraisers) -beginning balance \$6877.27, ending balance \$6895.36
 - d. Percussion account -beginning balance \$7758.65, ending balance \$7776.89
 - Treasurer report reviewed, motioned by Joellen Buller, seconded by Christa Ragle and approved.
- 4. Director's Report (Mr. Mewhorter)
 - a. Started marching practice outside with marching audition tomorrow and playing audition on 5/14/25. Percussion turned in their audition already, results will be posted soon. Guard auditions occurred last week, first rehearsal today. The show looks good on paper, will involve props with lights. The last grand nationals occurred in 2016, will attend in 2025. Received bond money this year that will help with band fees for the 2025-2026 year. Returned from Disney, trip went well and the kids enjoyed it and enjoyed the parents that went. Parents had a positive impact on the trip. Historical awards this year: triple sweepstakes with accent (every band received a 1 with jazz bands), winter guard made semi-finals at WGI -goal is to be an overall music program and not do it for the awards but we did have a historical awards year.  - f. Chaperones- Nothing new to report this year. There will be a need for medical crew to monitor 2 a days.
 - g. Merch- Nothing new to report at this time.
 - K. Color Guard- Auditions were already completed with 34 on the team and already practicing. The parent meeting already occurred. They will be fitted soon.
- 6. Old Business- Golf Cart -The golf cart used in the last few years was donated and no longer available. We are currently exploring options for the future. If anyone knows any opportunities for a golf cart, let the executive committee know about it
